- 2. On April 4, 2016, this Court entered an order granting a certificate of appealability, after the filing of Appellant's Informal Opening Brief.
- 3. On April 20, 2016, this Court entered an order granting the parties' motion to proceed with a deferred appendix pursuant to Rule 30(c), and entered the following briefing schedule:

4. Undersigned counsel has worked diligently on preparing the page-proof opening brief in this matter, but requests a short extension of seven (7) days of the current filing deadline to complete the brief, because of (a) the massive 30+ year size of the record in this unusual case; and (b) undersigned counsel's obligations in other federal matters, including preparation and presentation of an oral argument in this Court on May 12 (*U.S. v. Saunders*, No. 15-4498(L)) and involvement in a large discovery document production in a False Claims Act case

pending in the Eastern District of North Carolina (*U.S. v. Odyssey Marketing, et al.*, No. 5:15-CV-510-BO). In addition, undersigned counsel will be out of state with family from May 19, 2016 through May 23, 2016.
